SUBJECT: LOMAS LAGUNA NEIGHBORHOOD PERMIT PARKING

Dear Resident:

On February 8, 2022, the City of Laguna Hills adopted Resolution 2022-02-08-1 establishing a Residential Permit Parking Area consisting of no overnight street parking between the hours of 10:00 p.m. and 6:00 a.m. without a parking permit on streets in the Lomas Laguna Residential Neighborhood south of Alicia Parkway, specifically consisting of the following streets: (1) Ramona Street; (2) Yolanda Street; (3) Amalia Street; (4) Carmel Street; (5) Eva Street; (6) Lupita Street; (7) Patricia Street; (8) Rosa Street; (9) Andrea Street and (10) a segment of Louisa Street defined as beginning 700 feet westerly of the centerline of Moulton Parkway to the end of the cul de sac.

Please see the attached Parking Provisions document along with the application for Residential Permit Parking decals and placards. Please complete the application and provide a copy of the vehicle's current registration and necessary payment (\$15 for each decal) if you are interested in obtaining permits. You may pay by check or money order payable to the City of Laguna Hills. Please indicate on your application if you prefer to pay online with a credit card, and a staff member will contact you to make payment arrangements. Please return your application, copy of the vehicle's current registration and payment in the enclosed postage paid envelope.

**RESIDENTIAL PARKING PERMIT PROVISIONS
ON STREETS IN THE LOMAS LAGUNA RESIDENTIAL
NEIGHBORHOOD SOUTH OF ALICIA PARKWAY**

In accordance with City Council Resolution Nos. 2021-04-13-3, 2021-05-25-1 and Ordinance 94-4, the following actions were taken on February 8, 2022:

A Residential Permit Parking Area consisting of no overnight street parking between the hours of 10:00 p.m. and 6:00 a.m. without a parking permit is hereby established on streets in the Lomas Laguna Residential Neighborhood south of Alicia Parkway, specifically consisting of the following streets: (1) Ramona Street; (2) Yolanda Street; (3) Amalia Street; (4) Carmel Street; (5) Eva Street; (6) Lupita Street; (7) Patricia Street; (8) Rosa Street; (9) Andrea Street and (10) a segment of Louisa Street defined as beginning 700 feet westerly of the centerline of Moulton Parkway to the end of the cul de sac.

- A. Applications for residential parking permit decals as authorized herein may only be made by residents of the following streets: (1) Ramona Street; (2) Yolanda Street; (3) Amalia Street; (4) Carmel Street; (5) Eva Street; (6) Lupita Street; (7) Patricia Street; (8) Rosa Street; (9) Andrea Street and (10) a segment of Louisa Street defined as beginning 700 feet westerly of the centerline of Moulton Parkway to the end of the cul de sac.
- B. Applications shall be the sole responsibility of the applicant and shall be filed with the City Engineer, or his designated representative.
- C. Each applicant must be 18 years of age or older.
- D. Each residential property will receive one permit parking decal per vehicle registered to a resident of the property.
- E. Permit parking decals shall only be issued for personal passenger vehicles including pick-up trucks under two-ton capacity.
- F. Construction or commercial vehicles shall not qualify for issuance of a parking permit decal.
- G. Any parking permit decal issued pursuant to this Residential Permit Parking Program to a resident shall be valid for one year and shall only be issued to the registered owner of the vehicle, so long as the person to whom the permit is issued owns the vehicle and resides within the established residential permit parking area.
- H. Permit parking decals are non-transferable.
- I. Permit parking shall be prohibited on days and hours of City street sweeping.
- J. Permit parking is subject to the City's established consecutive 72-hour parking prohibition. (See, LHMC Sections 11-12.040 and 11-12.070.)
- K. Applicants for permit parking decals shall pay to the City a \$15 annual administrative fee for each decal and/or replacement.
- L. Four (4) guest permit/placards issued per residence, Guest parking permit placards shall require annual renewal and will only be issued to residents who obtain at least one permit parking decal.
- M. Parking permit decals may be issued for private service personnel as specified in LHMC § 11-24.060.
- N. Unlimited one-day special event permits issued upon request.
- O. A permit parking decal issued shall be permanently affixed to the left inside rear window of the vehicle for which it was issued.
- P. Guest or special event parking permit placards shall be displayed on the dashboard immediately above the steering wheel of the vehicle.
